1. Opening Prayer/Meditation: Deacon Andrea Paddock
2. Affirmation of Mission Statement: Nancy Skelley
3. Approval of Minutes: Bryan Price moved to approve the minutes for July 20, 2014. Seconded by Betty Mitchell. Motion passed with one abstention.
4. Treasurer's Report: Janet Chisholm shared the Profit and Loss Budget Performance and Balance Sheet for July, 2014 and reported on routine expenses. Morgan Stanley balance is at \$15,000 and the Sutton Trust reimbursement will be reflected in the August budget report. Nancy Skelley moved to approve the July, 2014 budget report. Seconded by Bryan Price. Motion passed.

  - A. Bishop Diane is scheduled to visit Faith on Tuesday, August 19, 2014.   - C. Mission Shares Grant: All parishes and missions contribute to the dioceses and a pool of money is divided up and distributed to those who submit grant requests. Faith submitted a grant request for \$20,000. \*
